O R D E R

The matter is before the Commission upon a motion filed by the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention ("AG"), requesting an extension of time in which to file the testimony of two of his experts, Messrs. Michael Majoros and Glenn Watkins, on or before April 26, 2010. In support of the motion, the AG states that counsel for Louisville Gas & Electric Company does not object to the request. In addition, the AG states that the testimony of his third and final witness will be timely filed in accordance with the procedural schedule. Lastly, the AG "represents that at no time prior to the filing of all of his testimony in this matter will counsel for the Attorney General nor his consultants read the testimony of the other intervenors in this matter, nor will they use the extension for the purpose of commenting on the testimony of the other intervenors."

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds good cause to grant the requested extension of time.

IT IS THEREFORE ORDERED that the AG's motion for an enlargement of time is granted.
