O R D E R

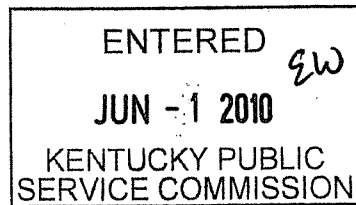
This matter is before the Commission upon Kentucky Cable Telecommunications Association's ("KCTA") motion for an extension of time in which to file its responses to Commission Staff's data request. Pursuant to the procedural schedule, intervenors' responses to data requests were due no later than May 19, 2010. KCTA stated that its counsel never received the data request propounded by Commission Staff and was unaware of its existence until May 19, 2010. Although it was uncertain why this occurred, KCTA noted that perhaps the incident may have been the result of KCTA's recent change in local counsel. Accordingly, KCTA requests that it be allowed an extension of time to May 24, 2010 to file its responses to Staff's data request. KCTA asserts that this extension would not prejudice any party because it would not impact the remainder of the procedural schedule.

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds that KCTA has established good cause to allow it an extension of time to file its responses to Staff's data request.

IT IS THEREFORE ORDERED that:

1. KCTA's motion for an extension of time to file responses to Staff's data request is granted.
2. KCTA shall file its responses to Staff's data request no later than May 24, 2010.
