INITIAL DATA REQUEST OF COMMISSION STAFF TO JOHNSON COUNTY GAS COMPANY

Johnson County Gas Company ("Johnson County"), pursuant to 807 KAR 5:001, is to file with the Commission the original and two copies of the following information, with a copy to all parties of record. The information requested herein is due within seven days of the date of this request. Responses to requests for information shall be appropriately bound, tabbed, and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Johnson County shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which

Johnson County fails or refuses to furnish all or part of the requested information, Johnson County shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations.

- 1. Refer to Schedule II of Johnson County's Gas Cost Recovery ("GCR") filing of January 4, 2010.
- a. Describe the terms under which Johnson County purchases gas from Constellation. Specifically, has Johnson County entered into a contract with Constellation that sets out how the purchase price for gas will be determined? If so, provide a copy of the contract. If not, explain the basis of the \$7.54 rate.
- b. Describe the terms under which Johnson County purchases gas from Bradco. Specifically, has Johnson County entered into a contract with Bradco that sets out a purchase price of \$8.50 per Mcf? If yes, provide a copy of the contract. If not, explain the basis of the \$8.50 rate.
- c. Describe the terms under which Johnson County purchases gas from Equitable Energy. Specifically, has Johnson County entered into a contract with Equitable Energy that sets out how the purchase price for gas will be determined? If yes, provide a copy of the contract. If not, explain the basis of the \$7.70 rate.

d. Explain the inclusion of Henry Hub as a supplier with a

corresponding rate of \$4.13 per Mcf for the purchase of 7,383 Mcf. From what entity did

Johnson County purchase this gas?

e. Are Constellation, Bradco, and Equitable Energy currently

supplying gas to Johnson County? Are there any additional suppliers?

2. Refer to the Actual Adjustment ("AA") calculations in Schedule IV of

Johnson County's GCR filing of January 4, 2010.

a. Provide support for the Mcf Supply Volumes Purchased and Cost of

Volumes Purchased for July, August, and September 2009. Include supplier invoices.

b. Provide AA calculations for the months of April, May, and June

2009, including support for volumes and cost.
