O R D E R

On January 8, 2010, Sharpsburg Water District ("Sharpsburg") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Sharpsburg purchases water from Bath County Water District ("Bath County") and the City of Carlisle.
2. On January 1, 2010, Bath County increased its rate for wholesale water service to Sharpsburg from \$2.73 per 1,000 gallons to \$2.79 per 1,000 gallons.<sup>2</sup>
3. Sharpsburg proposes to increase the water rates to its customers effective January 26, 2010.
4. During the 12 months ending November 30, 2009, Sharpsburg purchased a total of 77,680,000 gallons of water from Bath County and sold 83,317,800 gallons.

The increase in the cost of purchased water is \$4,660.80, resulting in a purchased water adjustment of \$0.06 per 1,000 gallons.

5. Sharpsburg calculated its proposed purchased water adjustment based upon an adjusted Bath County wholesale rate of \$2.78 per 1,000 gallons. As the Commission ultimately approved a wholesale rate of \$2.79 per 1,000 gallons, Sharpsburg's proposed purchase adjustment factor and the proposed rates derived from that factor are incorrect.

6. The rates proposed by Sharpsburg should be denied.

7. The purchased water adjustment of \$0.06 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

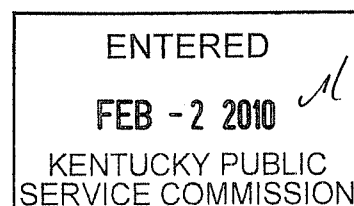
1. The proposed rates by Sharpsburg are denied.

2. The purchased water adjustment of \$0.06 per 1,000 gallons, as calculated in Appendix A, is approved.


3. The rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services on or after January 26, 2010.
