O R D E R


On February 2, 2010, the Commission entered an Order in this case in which it approved a purchased water adjustment for Sharpsburg Water District ("Sharpsburg"). The Order erroneously omitted a finding and a rate schedule in Appendix B.

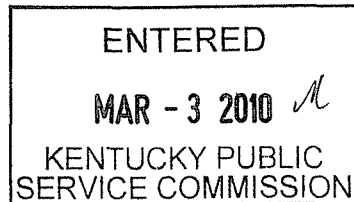
IT IS THEREFORE ORDERED to be entered, nunc pro tunc, that:

1. Finding paragraph 3 is corrected as follows: "Sharpsburg approved by resolution to pass on to Sharpsburg's customers the cost of water it purchases from Bath County Water District due to Bath County's increase in the wholesale rate. Sharpsburg proposes to increase the water rates to its customers effective January 26, 2010."
2. Appendix B of the Order of February 2, 2010 is revoked and is replaced by the Appendix to this Order to correct the omission of the Tank Truck Sales rate.
