ORDER

This matter arises upon the motion of the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention ("Attorney General") for full intervention. It appears to the Commission that such intervention is likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. The Commission also recognizes that an amended procedural schedule was established in this proceeding by Order dated May 17, 2010 and further amended by Order dated July 19, 2010. The Commission, being otherwise sufficiently advised, finds that the Attorney General should be granted full rights of a party in this proceeding and should accept the procedural schedule as it now stands.

1. The motion of the Attorney General to intervene is granted, and the Attorney General shall accept the existing procedural schedule.

- 2. The Attorney General shall be entitled to the full rights of a party and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.
- 3. Should the Attorney General file documents of any kind with the Commission in the course of these proceedings, the Attorney General shall also serve a copy of said documents on all other parties of record.
