COMMISSION STAFF'S FIRST SET OF INFORMATION  
REQUESTS TO WILMER AND PAULINE CONN


Wilmer and Pauline Conn, pursuant to 807 KAR 5:001, shall file with the Commission the original and ten copies of the following information. The information requested herein is due on or before September 13, 2010. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

The Conns shall make timely amendment to any prior response if they obtain information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which the Conns fail or refuse to furnish all or part of the requested information, the Conns shall provide a written explanation of the specific grounds for their failure to completely and precisely respond.

Careful attention should be given to copied material to ensure its legibility. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations.

1. State whether you own the property at 1860 Rock Lick Creek Road for which you seek water service from Fleming County Water Association ("FCWA").
2. If you do not own the property, identify the owner who must grant a utility easement in order for FCWA to serve the property.
3. Identify any restrictions on the deed of the property.
