An informal conference was held in this proceeding on May 20, 2010, wherein the parties expressed the need to have more time for continued negotiations, as provided in the informal conference memo issued on May 24, 2010. The Commission, upon its own motion, finds good cause to grant additional time for the parties to discuss and potentially resolve a number of outstanding issues and, therefore, the request for additional time for negotiations shall be granted.

IT IS HEREBY ORDERED that:

1. A telephonic informal conference shall be held on June 24, 2010 at 3:00 p.m., Eastern Daylight Time, at the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky.

2. At the informal conference, the parties shall provide an update on the status of the continued negotiations, including the resolution or narrowing of the list of issues to be included in the Decisions Point List provided by each party to this proceeding.

3. The parties shall be prepared to discuss the development of a procedural schedule and outline the threshold issues to be resolved by the Commission.
