ORDER

On February 12, 2010, Airview Utilities, LLC ("Airview") applied for authority to revise its rules and regulations and to establish or increase certain nonrecurring charges. More specifically, it proposed to initiate a returned check charge of \$20 and a termination of service charge of \$670 and to increase its reconnection of service charge of \$670.

On March 29, 2010, Commission Staff issued a request for information to Airview. Following an informal conference on May 11, 2010, Airview filed a partial response to this request on May 13, 2010. On June 24, 2010, it supplemented this response and also filed revised tariff sheets to conform with 807 KAR 5:011. In its revised tariff sheets, Airview proposed a termination of service charge of \$665 and a reconnection of service charge of \$665.

Commission Staff had requested that Airview obtain additional price quotes regarding the termination and reconnection of service. In its submission of June 24, 2010, Airview provided price quotes of \$1,100 and \$1,160 from local contractors. These quotes were significantly higher than the price quote that Airview provided to support the charges set forth in its application.

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Airview has provided adequate evidence of the individual expenses incurred to provide the services associated with the proposed nonrecurring charges.
- 2. The proposed nonrecurring charges are equal to the expenses incurred to provide the associated services.
- 3. The revised tariff sheets containing the utility's rates, rules and regulations filed in the case on June 24, 2010 should be approved.
- 4. The charges and policies set forth in the Appendix to this Order are fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. Airview's proposed rates as amended are approved.
- 2. The charges in the Appendix are approved for services rendered on and after the date of this Order.
 - 3. The revised tariff sheets filed in the case on June 24, 2010 are approved.
