ORDER

On May 12, 1993, in Case No. 1992-00331, the Commission approved rates for Western Lewis-Rectorville Water and Gas District ("Western Lewis") and provided for their further adjustment in accordance with Western Lewis's Gas Cost Adjustment ("GCA") clause.¹

On February 24, 2010, Western Lewis filed its proposed Gas Cost Recovery ("GCR") rate to be effective April 1, 2010.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Western Lewis's notice includes revised rates designed to pass on to its customers its expected change in gas costs.

- 2. Western Lewis's notice sets out an Expected Gas Cost ("EGC") of \$8.1210 per Mcf, which is an increase of \$.3592 per Mcf from its previous EGC of \$7.7618 per Mcf.
 - 3. Western Lewis's notice sets out no Refund Adjustment.
- 4. Western Lewis's notice sets out a current quarter Actual Adjustment ("AA") of \$.1152 per Mcf. Western Lewis omitted the Second Previous Quarter Reported Actual Adjustment of (\$.7112) in the calculation of its total AA, and it included a previous quarter AA of (\$.7701) that expires from rates with this filing. Correcting these errors produces a total AA of (\$1.6678) per Mcf, which is an increase of \$.8853 per Mcf from the previous total AA of (\$2.5531) per Mcf.
- 5. Western Lewis's notice sets out a current quarter Balance Adjustment ("BA") of (\$.0010) per Mcf. Western Lewis's total BA is (\$.0083) per Mcf, which is a decrease of \$.0046 per Mcf from the previous total BA of (\$.0037) per Mcf.
- 6. Western Lewis's GCR rate is \$6.4449 per Mcf, which is an increase of \$1.2399 per Mcf from the previous rate of \$5.2050 per Mcf.
- 7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Western Lewis on and after April 1, 2010.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are approved for service rendered on and after April 1, 2010.

2. Within 20 days of the date of this Order, Western Lewis shall file with this Commission its revised tariffs setting out the rates authorized herein and reflecting that they were approved pursuant to this Order.
