ORDER

On March 1, 2010, Cannonsburg Water District ("Cannonsburg") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Cannonsburg purchases water from the city of Ashland ("Ashland") and from the Big Sandy Water District ("Big Sandy").
- 2. Ashland notified Cannonsburg that it would increase its wholesale water rates effective March 15, 2010. Ashland's wholesale water rate to Cannonsburg would increase from \$1.89 per 1,000 gallons to \$2.01 per 1,000 gallons. Cannonsburg proposes to increase the water rates to its customers effective March 15, 2010.
- 3. During the 12 months ending November 30, 2009, Cannonsburg purchased a total of 459,997,000 gallons of water from Ashland and a total of 1,850,200 gallons of water from Big Sandy and sold a total of 319,113,200 gallons of water. The increase in the cost of purchased water is \$55,199.64, resulting in a purchased water adjustment of \$0.18 per 1,000 gallons.

4. A purchased water adjustment of \$0.18 per 1,000 gallons is fair, just, and reasonable.

IT IS HEREBY ORDERED that:

- 1. Cannonsburg's proposed rates are approved.
- 2. The purchased water adjustment increase of \$0.18 per 1,000 gallons as calculated in Appendix A is approved and the rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after March 15, 2010.
 - 3. The tariff sheets filed by Cannonsburg in the application are approved.
