ORDER

Kentucky Rural Water Association ("KRWA") has applied for accreditation of training that it proposes to present during April 2010 in various locations in Kentucky. The presentations for which approval is sought include instruction regarding Rural Development loans and grants, current ground water trends affecting utilities, proper record keeping and operational practices, and Kentucky Division of Water inspection procedures.

Pursuant to KRS 74.020(7), this Commission is required to "encourage and promote the offering of high quality water district management training programs that enhance a water district commissioner's understanding of his or her responsibilities and duties." Having reviewed the KRWA's application, the Commission finds that the proposed presentations will enhance a water district commissioner's understanding of his or her responsibilities and duties and should each be accredited for 2.0 hours of water district management training.

IT IS THEREFORE ORDERED that:

1. KRWA's Northeast Regional Meeting, which is scheduled to be held in Morehead. Kentucky on April 13, 2010, is approved for a maximum of 2.0 credit hours.

2. KRWA's Green River Regional Meeting, which is scheduled to be held in Owensboro, Kentucky on April 15, 2010, is approved for a maximum of 2.0 credit hours.

3. KRWA's Western Regional Meeting, which is scheduled to be held in Draffenville, Kentucky on April 22, 2010, is approved for a maximum of 2.0 credit hours.

4. KRWA shall retain a record of all persons attending the approved course

of instruction.

5. Within 14 days of the completion of each presentation, KRWA shall file

with the Commission:

a. A sworn statement attesting that the approved course of instruction

was performed;

b. If any changes in the speakers or course curriculum occurred after

KRWA's application, a description of those changes; and

c. The name of each water district commissioner who attended, his or

her water district, and the number of hours of training that he or she attended.

6. Any documents filed with the Commission pursuant to ordering paragraph

5 shall reference this case number and shall be filed in KRWA's general

correspondence file.

7. This case is closed and is removed from the Commission's docket.
