ORDER

On April 29, 2004, in Case No. 2003-00411,¹ the Commission approved rates for Equitable Gas Company ("Equitable"), a division of Equitable Resources, Inc., and provided for their further adjustment on a quarterly basis in accordance with Equitable's Gas Cost Adjustment ("GCA") clause.

On March 22, 2010, Equitable filed its proposed GCA to be effective May 1, 2010.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Equitable's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Equitable's Expected Gas Cost ("EGC") is \$7.1505 per Mcf, which is a decrease of \$.8263 per Mcf from its previous EGC of \$7.9768 per Mcf.
- 3. Equitable's notice sets out a current quarter Actual Adjustment ("AA") of (\$1.0297) per Mcf. Equitable's total AA is (\$2.4696) per Mcf, which is an increase of \$.0200 per Mcf from the previous total AA of (\$2.4896) per Mcf.

- 4. Equitable's notice sets out a current quarter Balancing Adjustment ("BA") of (\$.0023) per Mcf. Equitable's total BA is (\$.0762) per Mcf, which is a decrease of \$.0046 per Mcf from the previous total BA of (\$.0716) per Mcf.
- 5. Equitable's Gas Cost Recovery rate is \$4.6047 per Mcf, which is a decrease of \$.8109 per Mcf from its previous rate of \$5.4156 per Mcf.
- 6. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by Equitable on and after May 1, 2010.

IT IS THEREFORE ORDERED that:

- 1. The rates in the Appendix attached hereto and incorporated herein are approved for final meter readings on and after May 1, 2010.
- 2. Within 20 days of the date of this Order, Equitable shall file its revised tariffs with this Commission, setting out the rates authorized herein and reflecting that they were approved pursuant to this Order.
