ORDER

On March 31, 2010, Columbia Gas of Kentucky, Inc. ("Columbia") filed with this Commission its Accelerated Main Replacement Program Rider ("AMRP") 2010 annual update data, along with proposed increases to AMRP rates for customer classes subject to the rider. On April 12, 2010, the Commission issued its Order suspending the proposed AMRP rates and established a procedural schedule for the processing of this case. Columbia responded to two rounds of Commission Staff data requests. There are no intervenors in this proceeding. The case now stands submitted for decision.


