O R D E R

This matter arises upon the motion of Interstate Gas Supply, Inc. ("IGS"), SouthStar Energy Services, LLC ("SouthStar"), and Vectren Retail, LLC d/b/a Vectren Source ("Vectren"), filed May 28, 2010, for full intervention. It appears to the Commission that such interventions are likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. The Commission also recognizes that a procedural schedule was established in this proceeding by Order dated June 8, 2010. The Commission, being otherwise sufficiently advised, finds that IGS, SouthStar, and Vectren should be granted full rights of parties in this proceeding and should accept the procedural schedule as it now stands.

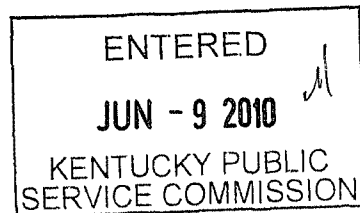
IT IS HEREBY ORDERED that:

1. The motion of IGS, SouthStar, and Vectren to intervene is granted, and IGS, SouthStar, and Vectren shall accept the existing procedural schedule.
2. IGS, SouthStar, and Vectren shall be entitled to the full rights of parties and shall be served with the Commission's Orders and with filed testimony, exhibits,

pleadings, correspondence, and all other documents submitted by parties after the date of this Order.

3. Should IGS, SouthStar, or Vectren file documents of any kind with the Commission in the course of these proceedings, IGS, SouthStar and Vectren shall also serve a copy of said documents on all other parties of record.
