O R D E R

Woodland Acres Utilities, LLC ("Woodland Acres, LLC") filed an application on May 3, 2010 for the transfer of Woodland Acres Wastewater Treatment Plant and collection system. In a related matter, Case No. 2009-00378,¹ the Commission is investigating the condition of the Woodland Acres Sanitation, Inc. sewage treatment system, which is one and the same as Woodland Acres, LLC. Case No. 2009-00378 was established to determine whether or not Woodland Acres, LLC has been abandoned and, if so, whether a receiver should be required pursuant to KRS 278.021.

At an informal conference held immediately following the adjournment of the June 4, 2010 formal hearing in Case No. 2009-00378, Commission Staff and Woodland Acres, LLC discussed the responses to the questions contained in Appendix A attached to the procedural Order scheduling the June 4, 2010 informal conference in this case. It was determined that Woodland Acres, LLC would provide additional documents and file responses to questions 4-8 of the Appendix to the June 4, 2010 Order.

KRS 278.020(6) provides that the Commission shall approve or deny such an application within 60 days of filing unless it finds that it is necessary, for good cause, to extend the application for an additional 60 days. The application in this case was filed May 3, 2010 and would require action by July 2, 2010.


Therefore, we find that, due to the pending abandonment proceeding in Case No. 2009-00378 and the time necessary for Commission Staff to examine the additional information to be supplied by Woodland Acres, LLC in this matter, good cause has been presented to extend the application for an additional 60 days.

The Commission, on its own motion, **HEREBY ORDERS** that Woodland Acres, LLC's application in this proceeding is continued for a period not to exceed 60 days, from July 2, 2010 through September 1, 2010.
