O R D E R

On May 10, 2010, Jessamine County Water District No. 1 (“Jessamine County”) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Jessamine County purchases water from the city of Nicholasville (“Nicholasville”).

2. Nicholasville notified Jessamine County, effective with its June 1, 2010 billing, Nicholasville’s wholesale water rate to Jessamine County would increase from \$2.43 per 1,000 gallons to \$2.73 per 1,000 gallons. Jessamine County proposes to increase the water rates to its customers effective June 15, 2010.

3. During the 12 months ending March 31, 2010, Jessamine County purchased a total of 198,010,000 gallons of water and sold 163,495,000 gallons. The

increase in the cost of purchased water is \$59,403, resulting in a purchased water adjustment of \$0.36 per 1,000 gallons.

4. The rates proposed by Jessamine County should be approved.

5. The purchased water adjustment of \$0.36 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

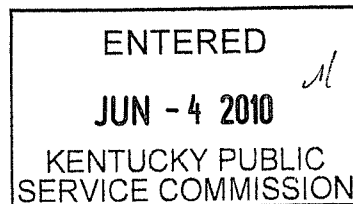
1. The rates proposed by Jessamine County are approved.

2. The purchased water adjustment of \$0.36 per 1,000 gallons as calculated in Appendix A is approved.


3. The rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for service on or after June 15, 2010.
