ORDER

On December 29, 2009, in Case No. 2009-00202,¹ the Commission approved rates for Duke Energy Kentucky, Inc. ("Duke") and provided for their further adjustment in accordance with Duke's Gas Cost Adjustment ("GCA") clause.

On May 13, 2010, Duke filed its GCA to be effective June 2, 2010.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Duke's notice includes rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Duke's Expected Gas Cost ("EGC") is \$6.402 per Mcf, which is an increase of \$.636 per Mcf from its previous EGC of \$5.766 per Mcf.
- 3. Duke's notice sets out a current quarter Refund Adjustment ("RA") of (\$.002) per Mcf. Duke's total RA is (\$.003) per Mcf, which is a decrease of \$.002 per Mcf from its previous total RA of (\$.001) per Mcf.

- 4. Duke's notice sets out a current quarter Actual Adjustment ("AA") of \$.104 per Mcf. Duke's total AA is \$.133 per Mcf, which is an increase of \$.138 per Mcf from its previous total AA of (\$.005) per Mcf.
- 5. Duke's notice sets out a current quarter Balancing Adjustment ("BA") of (\$.007) per Mcf. Duke's total BA is (\$.017) per Mcf, which is an increase of \$.025 per Mcf from its previous total BA of (\$.042) per Mcf.
- 6. Duke's Gas Cost Recovery ("GCR") rate is \$6.515 per Mcf, which is an increase of \$.797 per Mcf from its previous GCR of \$5.718 per Mcf.
- 7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by Duke on and after June 2, 2010.

IT IS THEREFORE ORDERED that:

- 1. The rates in the Appendix to this Order are approved for final meter readings on and after June 2, 2010.
- 2. Within 20 days of the date of this Order, Duke shall file its revised tariffs with this Commission setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
