ORDER

On July 21, 2010, the Kentucky State Board on Electric Generation and Transmission Siting ("Siting Board") issued a procedural schedule that provided for a local public hearing in Henderson, Kentucky at a date, time, and location to be determined.

The Siting Board, on its own motion, HEREBY ORDERS that:

- 1. A local public hearing shall be held on September 2, 2010 at the Henderson Fine Arts Center, 2660 South Green Street, Henderson, Kentucky 42420, beginning at 5:30 p.m., Central Daylight Time.
- 2. Southern Indiana Gas & Electric Co. d/b/a Vectren Energy Delivery of Indiana, Inc. ("Vectren") and any party to the case shall be afforded the opportunity at the local public hearing to make a public presentation regarding the proposed transmission line project. The names of all attendees, a summary of oral comments, and any written comments or presentation materials shall be recorded by the Siting Board and filed in the administrative record of this matter.

3. Pursuant to 807 KAR 5:110, Section 8(2), Vectren shall publish notice of the September 2, 2010 local public hearing on or before August 13, 2010 in a newspaper of general circulation in Henderson County, Kentucky and Webster County, Kentucky. Vectren shall file proof of publication with the Siting Board on or before August 27, 2010.

4. All other provisions of the July 21, 2010 procedural schedule shall remain in full force and effect, except that the last day for the Siting Board to issue a decision on the merits of this case shall be November 12, 2010.
