O R D E R

This matter arises upon the jointly filed motion of Applicant, Southern Indiana Gas & Electric Co. d/b/a Vectren Energy Delivery of Indiana, Inc. ("Vectren"), and the Intervenor, the City of Henderson, Henderson Water Utility, and Henderson Municipal Power & Light to reschedule the evidentiary hearing previously scheduled to be held on October 13, 2010 at the offices of the Kentucky Public Service Commission and to reschedule the final date for filing direct testimony in this matter, which is currently October 8, 2010.

In support of their motion, the parties state that they have "reached an agreement in principle on all major issues and are reducing those agreements to writing" and

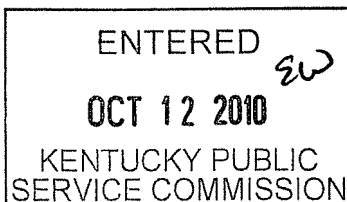
In light of the agreement and the necessity to finalize the documents in question, including the filing of an Amended Application in this matter, it is necessary for the parties to request that the Board reschedule the deadline to file direct testimony, and the date for the formal hearing in this matter.

Based on the parties' joint motion, the Kentucky State Board on Electric Generation and Transmission Siting finds good cause to reschedule the October 13, 2010 evidentiary hearing in this matter.


IT IS THEREFORE ORDERED that:

1. The evidentiary hearing in this matter is rescheduled to October 21, 2010 at 10:00 a.m., Eastern Daylight Time, at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky.
2. The parties shall file their witnesses' direct testimony on or before October 18, 2010.
3. Vectren shall comply with the notice requirements pursuant to 807 KAR 5:110, Section 9(1), unless it files an amended application in this matter on or before October 15, 2010.
