O R D E R

On October 19, 2007, in Case No. 2007-00089,<sup>1</sup> the Commission approved rates for Delta Natural Gas Company, Inc. ("Delta") and provided for their further adjustment in accordance with Delta's Gas Cost Adjustment ("GCA") clause.

On June 24, 2010, Delta filed its proposed GCA to be effective July 26, 2010.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Delta's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Delta's notice sets out an Expected Gas Cost ("EGC") of \$6.7499 per Mcf, which is an increase of \$.5467 per Mcf from the previous EGC of \$6.2032 per Mcf.
3. Delta's notice sets out no current quarter Refund Adjustment ("RA"), which is no change from the previous total RA.

4. Delta's notice sets out a current quarter Actual Adjustment ("AA") of (\$.5276) per Mcf. Delta's total AA is \$.8926 per Mcf, which is an increase of \$.9914 per Mcf from the previous total AA of (\$.0988) per Mcf.

5. Delta's notice sets out a Balance Adjustment ("BA") of (\$.1761) per Mcf, which represents a decrease of \$.3079 per Mcf from the previous BA of \$.1318 per Mcf.

6. Delta's GCA is \$7.4664 per Mcf, which is an increase of \$1.2302 per Mcf from the previous GCA of \$6.2362 per Mcf.

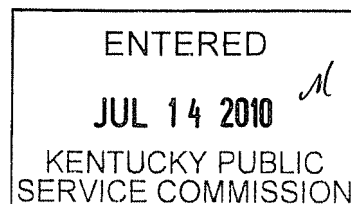
7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by Delta on and after July 26, 2010.

IT IS THEREFORE ORDERED that:


1. The rates in the Appendix to this Order are approved for final meter readings on and after July 26, 2010.
