## ORDER

- 1. The Affidavit of Publication filed by Kenergy Corp. ("Kenergy") in the above-referenced matter on October 6, 2010 indicates that Kenergy published notice of the formal hearing scheduled for October 12, 2010 in its service counties of Caldwell, Daviess, Hancock, Henderson, Hopkins, Lyon, McLean, Ohio, and Webster counties.
- 2. Kenergy published notice of the formal hearing scheduled on October 12, 2010 in the Princeton <u>Times-Leader</u> on August 25, 2010, outside the time frame directed in the Commission's August 13, 2010 Order for publishing notice of the formal hearing to be held on October 12, 2010.
- 3. KRS 424.120(3) states that if a publication area consists of a district, other than a city, which extends into more than one county, the part of the district in each county shall be considered to be a separate publication area and an advertisement for each separate publication area is required to be published in a qualified newspaper.
- 4. Kenergy serves customers in Breckinridge, Caldwell, Crittenden, Daviess, Hancock, Henderson, Hopkins, Livingston, Lyon, McLean, Muhlenberg, Ohio, Union, and Webster counties.

- 5. Kenergy did not publish notice of the formal hearing scheduled on October 12, 2010 in its service counties of Breckinridge, Crittenden, Livingston, Muhlenberg, or Union.
- 6. The notice of formal hearing published by Kenergy in the Caldwell County newspaper, the Princeton <u>Times-Leader</u>, on August 25, 2010 was outside the time frame directed in the August 13, 2010 Commission's Order directing notice of the formal hearing.

Pursuant to 807 KAR 5:056, Section 1(11), and KRS 424.120, IT IS HEREBY ORDERED that:

- 1. A public hearing shall be held on December 13, 2010 at 10:00 a.m., Eastern Standard Time, at the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, to examine the application of the Fuel Adjustment Clause of Kenergy from November 1, 2009 through April 30, 2010. If no interested party files written notice of its intent to attend this hearing with the Commission by December 9, 2010, this public hearing is cancelled and the matter shall be considered submitted for decision based on the evidence in the record.
- 2. Kenergy shall publish the following notice no less than seven days nor more than 21 days prior to the public hearing in a newspaper of general circulation in its service areas in which notice was not previously published (Breckinridge, Crittenden, Livingston, Muhlenberg, and Union counties) and in its service area of Caldwell County, or in a trade publication or newsletter going to all customers. Kenergy shall file an Affidavit of Publication of Hearing Notice with the Commission no later than December 9, 2010.

A public hearing will be held on December 13, 2010, at 10:00 a.m., Eastern Standard Time, at the offices of the Service Commission, 211 Sower Boulevard, Public Frankfort, Kentucky, to examine the application of the fuel adjustment clause of Kenergy Corp. for the period November 1, 2009 through April 30, 2010. Individuals interested in attending this hearing shall notify the Public Service Commission in writing of their intent to attend no later than December 9, 2010. If no notices of intent to attend are received by that date, this hearing will be cancelled, and the matter shall be considered submitted for decision based on the evidence in the record. Written notice of intent to attend this hearing should be sent to: Executive Director, Public Service Commission, P.O. Box 615, Frankfort, Kentucky 40602.
