
ORDER

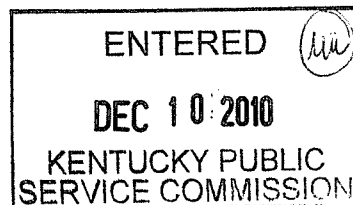
