- 4. KCTA shall comply with all provisions of the Commission's Order of November 5, 2010 related to the electronic filing of documents.

5. Within five days of entry of this Order, KCTA shall:

a. Notify the Commission and all other parties of record in writing of

the electronic mail address to which all electronic notices and messages related to this

proceeding should be served.

b. File a written statement as to whether it, or its agent, is capable of

receiving electronic transmissions, and whether it waives any right to service of

Commission Orders by United States mail.
