ORDER

On November 5, 2010, West Carroll County Water District ("West Carroll") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. West Carroll purchases water from Carrollton Utilities ("Carrollton"), Henry County Water District No. 2 ("Henry County"), city of Milton ("Milton"), and Trimble County Water District No. 1 ("Trimble County").
- 2. Henry County notified West Carroll that it would increase its wholesale water rates effective August 12, 2010. Henry County's wholesale water rate to West Carroll would increase from \$2.20 per 1,000 gallons to \$2.58 per 1,000 gallons.
- West Carroll increased its water rates to its customers effective November
 2010.
- 4. During the 12 months ending September 30, 2010, West Carroll purchased a total of 62,368,815 gallons of water from Carrollton, 2,130,071 gallons of water from Henry County, 588,271 gallons of water from Milton, and 1,146,028

gallons of water from Trimble County, and sold a total of 52,039,069 gallons of water. The increase in the cost of purchased water is \$809.43, resulting in a purchased water adjustment of \$0.02 per 1,000 gallons.

5. A purchased water adjustment of \$0.02 per 1,000 gallons is fair, just, and reasonable.

IT IS HEREBY ORDERED that:

- 1. West Carroll's proposed rates are approved.
- 2. The purchased water adjustment increase of \$0.02 per 1,000 gallons as calculated in Appendix A and the rates in Appendix B are approved for services rendered on and after November 3, 2010. Those appendices are attached hereto and incorporated herein.
 - 3. The tariff sheet filed by West Carroll in the application is approved.
