ORDER

On November 22, 2010, Morgan County Water District ("Morgan County") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Morgan County purchases water from West Liberty Water Works ("West Liberty") and Cave Run Water Commission ("Cave Run").

2. West Liberty notified Morgan County that, effective January 1, 2011, West Liberty's wholesale water rate to Morgan County would increase from \$2.67 per 1,000 gallons to \$2.79 per 1,000 gallons. Morgan County proposes to increase the water rates to its customers effective January 1, 2011.

3. During the 12 months ending October 31, 2010, Morgan County purchased 107,522,000 gallons of water from Cave Run and 121,368,000 gallons of water from West Liberty. During that period, Morgan County sold 149,189,890 gallons

of water. The increase in the cost of purchased water is \$14,564.16, resulting in a purchased water adjustment of \$0.10 per 1,000 gallons.

4. Morgan County's proposed rates should be approved.

5. The purchased water adjustment of \$0.10 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:


1. Morgan County's proposed rates are approved.

2. The purchased water adjustment of \$0.10 per 1,000 gallons as calculated in Appendix A is approved.

3. The rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on or after January 1, 2011.

Within 20 days of the date of this Order, Morgan County shall file revised 4. tariff sheets with the Commission showing the rates approved herein.
