#### ORDER

On November 24, 2010, Larue County Water District No. 1 ("Larue County") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Larue County purchases water from Green River Valley Water District ("Green River"), City of Hodgenville ("Hodgenville"), City of Bardstown ("Bardstown"), the city of New Haven ("New Haven"), City of Campbellsville ("Campbellsville"), and Green Taylor Water District ("Green Taylor").
- 2. Green River notified Larue County that it would increase its wholesale water rates effective November 5, 2010. Green River's wholesale water rate to Larue County would increase from \$1.58 per 1,000 gallons to \$2.14 per 1,000 gallons.
- 3. On November 8, 2010, Larue County's Board of Commissioners voted to increase the water rates to its customers effective November 8, 2010, in an amount commensurate with the increase in Green River's wholesale rate.

- 4. Larue County's computation of the proposed rates contained a mathematical error.
- 5. During the 12 months ending October 31, 2010, Larue County purchased a total of 86,793,600 gallons of water from Green River, 47,101,000 gallons of water from Hodgenville, 35,031,800 gallons of water from Bardstown, 12,552,300 gallons of water from New Haven, 5,279,600 gallons of water from Campbellsville, and 1,998,800 gallons of water from Green Taylor, and sold a total of 165,033,570 gallons of water. The increase in the cost of purchased water is \$48,604.42, resulting in a purchased water adjustment of \$0.30 per 1,000 gallons.
- 6. A purchased water adjustment of \$0.30 per 1,000 gallons is fair, just, and reasonable.

#### IT IS HEREBY ORDERED that:

- 1. Larue County's proposed rates are denied.
- 2. The purchased water adjustment increase of \$0.30 per 1,000 gallons as calculated in Appendix A is approved. The rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after November 8, 2010.
- 3. Within 20 days of the date of this Order, Larue County shall file revised tariff sheets with the Commission showing the rates approved herein.
