

On February 10, 2011, BellSouth Telecommunications, Inc. d/b/a AT&T Kentucky and Sprint Spectrum L.P., Nextel West Corp., and NPCR, Inc. d/b/a Nextel Partners and Sprint Communications Company L.P. jointly filed with the Commission a Motion to Withdraw Petition and Close Docket. As grounds for their motion, the parties state that they have reached an agreement to extend their current interconnection agreement to March 1, 2012.
