## <u>O R D E R</u>

Pursuant to our Order of July 28, 2011, Complainant, Bulldog's Enterprises, Inc. d/b/a Bulldog's Road House, was required to file its responses to Commission Staff's first data requests within seven days from the issuance of the Order. On August 9, 2011, Complainant filed responses to data requests that had been submitted to Complainant by Defendant, Duke Energy Kentucky, Inc.<sup>1</sup> Complainant, however, has not filed its responses to Commission Staff's initial data requests. It appears to the Commission that Complainant has inadvertently filed the wrong response. The Commission, therefore, will allow Complainant additional time to file the appropriate response to Commission Staff's data requests, which were originally issued to Complainant on June 30, 2011, and which were appended to our July 28, 2011 Order. In light of this second extension of time, the Commission will suspend the current

procedural schedule and will issue another revised procedural schedule once Complainant has filed its responses to Commission Staff's initial data requests.

2. The current procedural schedule established by our July 28, 2011 Order is suspended until further notice.
