ORDER

West McCracken County Water District ("West McCracken District") applied for authority to increase its water rates. By this Order, we establish rates that will produce annual revenues from water sales of \$653,343, an increase of \$84,453, or 14.85 percent, over normalized revenue from rates of \$568,890. The approved rates will increase the average monthly residential bill of 5,000 gallons from \$28.94 to \$33.25, an increase of \$4.31, or 14.9 percent.

West McCracken District, a water district organized pursuant to KRS Chapter 74, owns and operates facilities that distribute and furnish water to approximately 1,489 customers in western McCracken County, Kentucky.¹ It is a utility subject to Commission jurisdiction.² West McCracken District's most recent general rate adjustment occurred in 2007.³

West McCracken District's application for general rate adjustment was filed with the Commission on December 16, 2010.⁴ West McCracken District's proposed rates would increase the average monthly residential bill of 5,000 gallons from \$28.94 to \$31.87, an increase of \$2.94, or 10.1 percent,⁵ and would generate annual revenues from water sales of \$626,293.⁶ West McCracken District proposed to place its rates into effect on January 25, 2011. Finding that further investigation of the proposed rates was necessary, the Commission suspended the operation of the proposed rates for five months and initiated this proceeding.

The Commission directed Commission Staff to perform a limited financial review of West McCracken's test-period operations. On June 8, 2011, Commission Staff issued a report containing its findings and recommendations in which it found that West McCracken District's pro forma operations supported a revenue requirement of \$760,601. Commission Staff further found that West McCracken District's requested revenue requirement of \$626,293 from water sales would produce a positive cash flow of \$72,475, would be sufficient for West McCracken to pay its pro forma "cash" expenses, and would allow West McCracken to meet its existing debt service obligations. Commission Staff recommended that the Commission approve the proposed rates.

On June 8, 2011, the Commission released Commission Staff's report and directed West McCracken District to submit any written comments on or objections to the report's findings and recommendations within 14 days. We directed West McCracken District to file in writing with the Commission its position on adjusting its rates to the level that would produce annual revenues of \$760,601. We further directed West McCracken District to respond to Commission Staff's findings regarding the appropriateness of rates that would produce annual revenues of \$760,601 and to state its intentions regarding those rates. Finally, we directed West McCracken District, if it wished to receive such rates, to publish notice of its intentions to its customers.

On June 13, 2011, West McCracken District notified the Commission in writing of its intent to place its proposed rates into effect on June 25, 2011. On June 22, 2011, West McCracken District advised the Commission in writing that rates producing annual revenues of \$760,601 "would place an undue burden on its ratepayers" and that it declined to request such rates. Instead, it requested its present rates be increased approximately 15 percent rather than the ten percent reflected in its application. West

McCracken District also provided proof that notice of its request had been mailed to its customers. As of the date of this Order, the Commission has not received any comments regarding West McCracken District's request.⁹

Having considered the evidence of record and being otherwise sufficiently advised, the Commission finds that:

- The findings and recommendations contained in the Commission Staff's report are supported by the evidence of record, are reasonable, and should be adopted.
- 2. The calendar year ending December 31, 2009 should be used as the test period to determine the reasonableness of West McCracken District's existing and proposed rates.
- 3. Based upon pro forma test-period operations, West McCracken District's pro forma annual revenues are \$591,577. Approximately \$568,890 of these revenues resulted from water sales.
- 4. Based upon pro forma test-period operations, West McCracken District's pro forma total operating expenses, after adjusting for known and measurable changes, is \$708,073.
- 5. Given that West McCracken District is a water district, the use of debt service coverage methodology to determine its total revenue requirement is appropriate.
- 6. The use of a debt service coverage ratio of 1.1x should be used to determine West McCracken District's total revenue requirement.
- 7. Applying a debt service coverage of 1.1x to West McCracken District's average debt service requirement for the period from 2011 to 2013 produces a total

revenue requirement of \$760,601, or \$191,711 more than the rates in effect as of December 16, 2010 produce.

- 8. The proposed rates set forth in West McCracken District's application will produce total annual revenues from test period sales of \$626,293.
- 9. In light of Commission Staff's findings and recommendations, West McCracken District has proposed that the Commission authorize rates that produce total annual revenues of \$653,343, an increase of \$84,453, or 14.85 percent, over normalized revenue from rates of \$568,890.
- 10. Based upon test-period operations, West McCracken District, if authorized rates that produce total annual revenues of \$653,343 from water sales, will have a positive cash flow of \$76,768¹⁰ and will be able meet its pro forma "cash" expenses and debt service requirements.
- 11. The rates set forth in the Appendix to this Order will produce annual revenues of \$653,343 from water sales. Implementation of these rates is not likely to cause the service that West McCracken District renders to the public to suffer.
- 12. When a utility has requested rates that are less than a regulatory commission determines "would furnish a fair return then, in the absence of some factor which would in the public interest require that larger rates be charged, the rates requested by the utility ought to be allowed."

13. The rates set forth in the Appendix to this Order should be approved for water service that West McCracken District renders on and after the date of this Order. 12

IT IS THEREFORE ORDERED that:

- 1. The findings and recommendations contained in the Commission Staff's report are adopted and incorporated by reference into this Order as if fully set out herein.
- 2. The rates for water service set forth in West McCracken District's application are denied.
- 3. West McCracken District is authorized to assess the rates set forth in the Appendix to this Order for service rendered on and after the date of this Order.
- 4. Within 20 days of the date of this Order, West McCracken District shall file revised tariff sheets with the Commission setting forth the rates approved in this Order.
