ORDER

On December 2, 2010, Cannonsburg Water District ("Cannonsburg") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Cannonsburg purchases water from the city of Ashland ("Ashland") and Big Sandy Water District.
- 2. Ashland notified Cannonsburg that, effective January 1, 2011, Ashland's wholesale water rate to Cannonsburg would increase from \$2.01 per 1,000 gallons to \$2.12 per 1,000 gallons.
- 3. Cannonsburg proposes to increase the water rates to its customers effective January 1, 2011.
- 4. During the 12 months ending August 31, 2010, Cannonsburg purchased a total of 529,046,000 gallons of water from Ashland and sold 365,379,400 gallons. The increase in the cost of purchased water is \$58,195.06 and results in a purchased water adjustment of \$0.16 per 1,000 gallons.

- 5. Cannonsburg incorrectly applied the purchased water adjustment to the minimum bill for 12" meter customers as well as its leak adjustment rate.
 - 6. Cannonsburg's proposed rates should be denied.
- 7. The purchased water adjustment of \$0.16 per 1,000 gallons is fair, just, and reasonable and should be approved.
- 8. The rates set forth in Appendix B are fair, just, and reasonable and should be charged for water service that Cannonsburg renders on and after January 1, 2011.

IT IS THEREFORE ORDERED that:

- 1. Cannonsburg's proposed rates are denied.
- 2. The purchased water adjustment of \$0.16 per 1,000 gallons as calculated in Appendix A is approved.
- 3. The rates in Appendix B are approved for water service that Cannonsburg renders on or after January 1, 2011.
- 4. Within 20 days of the date of this Order, Cannonsburg shall file revised tariff sheets with the Commission showing the rates approved herein.
