### ORDER

On December 6, 2010, Monroe County Water District ("Monroe District") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Monroe District purchases water from the City of Tompkinsville ("Tompkinsville").
- 2. Tompkinsville notified Monroe District that, effective with its January 1, 2011 billing, Tompkinsville's wholesale water rate to Monroe District would increase from \$1.39 per 1,000 gallons to \$1.53 per 1,000 gallons.
- 3. Monroe District proposes to increase the water rates to its customers effective January 1, 2011.
- 4. During the 12 months ending September 30, 2010, Monroe District purchased a total of 270,932,200 gallons of water and sold 217,912,590 gallons. The increase in the cost of purchased water is \$37,930.51 resulting in a purchased water adjustment of \$0.18 per 1,000 gallons.

- 5. Monroe District did not apply the purchased water adjustment to its leak adjustment rate.
  - 6. The rates proposed by Monroe District should be denied.
- 7. The purchased water adjustment of \$0.18 per 1,000 gallons is fair, just, and reasonable and should be approved.
- 8. In the proposed rates filed by Monroe District, the utility failed to adjust its leak adjustment rate.

### IT IS THEREFORE ORDERED that:

- 1. The proposed rates by Monroe District are denied.
- 2. The purchased water adjustment of \$0.18 per 1,000 gallons as calculated in Appendix A is approved.
- 3. The rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services on or after January 1, 2011.
- 4. Within 20 days of the date of this Order, Monroe District shall file revised tariff sheets with the Commission showing the rates approved herein.
