ORDER

On December 8, 2010, Big Sandy Water District ("Big Sandy") applied for approval to adjust its rates commensurate with an increase in rates by the Cannonsburg Water District ("Cannonsburg"), pursuant to the purchased water adjustment procedure.<sup>1</sup> On December 28, 2010, Big Sandy filed a request to amend the application to account for a decrease in rates by the city of Kenova, West Virginia ("Kenova").

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Big Sandy purchases water from Cannonsburg, Kenova, the city of Louisa ("Louisa"), and Rattlesnake Ridge Water District ("Rattlesnake Ridge").
2. Cannonsburg raised its wholesale rate to Big Sandy, effective January 1, 2011, from \$2.50 per 1,000 gallons to \$2.66 per 1,000 gallons.
3. Kenova decreased its wholesale rate to Big Sandy, effective November 19, 2010, from \$1.89 per 1,000 gallons to \$1.79 per 1,000 gallons.

4. Big Sandy proposed a purchased water adjustment factor of \$0.03 per 1,000 gallons.<sup>2</sup>

5. Big Sandy proposed an effective date of January 1, 2011.

6. During the 12 months ending November 30, 2010, Big Sandy purchased 82,650,100 gallons of water from Louisa, 227,589,000 gallons of water from Kenova, 4,694,630 gallons of water from Rattlesnake Ridge, and 51,200,700 gallons of water from Cannonsburg, and sold 295,760,400 gallons of water. The decrease in the cost of purchased water is (\$14,567), resulting in a purchased water adjustment factor of (\$0.05) per 1,000 gallons.

7. The purchased water adjustment factor of (\$0.05) per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Big Sandy are denied.

2. The purchased water adjustment factor of (\$0.05) per 1,000 gallons as calculated in Appendix A is approved.

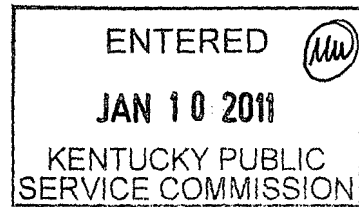
3. The rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services on or after January 1, 2011.

4. Within 20 days of the date of this Order, Big Sandy shall file revised tariff sheets with the Commission showing the rates approved herein.
