### ORDER

On October 21, 2010, in Case No. 2010-00116,<sup>1</sup> the Commission approved rates for Delta Natural Gas Company, Inc. ("Delta") and provided for their further adjustment in accordance with Delta's Gas Cost Adjustment ("GCA") clause.

On December 22, 2010, Delta filed its proposed GCA to be effective January 24, 2011.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Delta's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Delta's notice sets out an Expected Gas Cost ("EGC") of \$5.1463 per Mcf, which is an increase of \$.2283 per Mcf from the previous EGC of \$4.9180 per Mcf.
- 3. Delta's notice sets out no current quarter Refund Adjustment ("RA"). Delta's total RA is (\$.0072) per Mcf, which is no change from the previous quarter.

- 4. Delta's notice sets out a current quarter Actual Adjustment ("AA") of \$.5666 per Mcf. Delta's total AA is \$1.7354 per Mcf, which is an increase of \$.5259 per Mcf from the previous total AA of \$1.2095 per Mcf.
- 5. Delta's notice sets out a Balance Adjustment ("BA") of (\$.0225) per Mcf, which represents a decrease of \$.0731 per Mcf from the previous BA of \$.0506 per Mcf.
- 6. Delta's GCA is \$6.8520 per Mcf, which is an increase of \$.6811 per Mcf from the previous GCA of \$6.1709 per Mcf.
- 7. The rates in the Appendix to this Order are fair, just, and reasonable and should be approved for final meter readings by Delta on and after January 24, 2011.

#### IT IS THEREFORE ORDERED that:

- 1. The rates in the Appendix to this Order are approved for final meter readings on and after January 24, 2011.
- 2. Within 20 days of the date of this Order, Delta shall file its revised tariff sheets with this Commission setting out the rates authorized herein and reflecting that they were approved pursuant to this Order.
