ORDER

On October 10, 1986, in Case No. 9565,¹ the Commission approved rates for Public Gas Company ("Public") and provided for their further adjustment in accordance with Public's Gas Cost Adjustment ("GCA") clause.

On January 3, 2011, Public filed its proposed GCA to be effective February 1, 2011.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Public's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Public's proposed Expected Gas Cost ("EGC") is \$6.6302 per Mcf, which is a decrease of \$.2447 per Mcf from the previous EGC of \$6.8749 per Mcf.
3. Public's notice sets out no current quarter Refund Adjustment.

4. Public's notice sets out a current quarter Actual Adjustment ("AA") of (\$.0551) per Mcf. Public's total AA of (\$.8713) per Mcf is an increase of \$.0422 per Mcf from the previous total AA of (\$.9135) per Mcf.

5. Public's GCA is \$5.7589 per Mcf, which is a decrease of \$.2025 per Mcf from the previous GCA of \$5.9614 per Mcf.

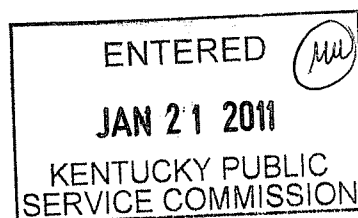
6. The rates in the Appendix to this Order are fair, just, and reasonable and should be approved for billing for service rendered by Public on and after February 1, 2011.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing for service rendered on and after February 1, 2011.

2. Within 20 days of the date of this Order, Public shall file its revised tariffs with this Commission, setting out the rates authorized herein and reflecting that they were approved pursuant to this Order.
