ORDER

On October 31, 2008, in Case No. 2008-00032,<sup>1</sup> the Commission approved rates for Burkesville Gas Company (“Burkesville”) and provided for their further adjustment on a monthly basis in accordance with Burkesville’s Gas Cost Adjustment (“GCA”) clause.

On January 3, 2011, Burkesville filed its proposed GCA to be effective February 1, 2011.

After reviewing the evidence of record and being otherwise sufficiently advised, the Commission finds that:

1. Burkesville’s notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Burkesville’s proposed Expected Gas Cost (“EGC”) is \$8.5376 per Mcf, which is a decrease of \$.1052 per Mcf from the prior EGC of \$8.6428 per Mcf.
3. Burkesville’s notice sets out no Refund Adjustment.

4. Burkesville's notice sets out a current Actual Adjustment ("AA") of (\$.0564) per Mcf. Burkesville's total AA of (\$3.6106) per Mcf represents a decrease of \$.0564 per Mcf from the previous total AA of (\$3.5542) per Mcf.

5. Burkesville's GCA is \$4.9270 per Mcf, which is a decrease of \$.1616 per Mcf from the previous GCA of \$5.0886 per Mcf.

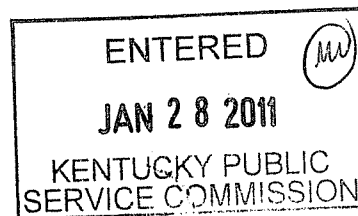
6. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Burkesville on and after February 1, 2011.

IT IS THEREFORE ORDERED that:


1. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing for service rendered on and after February 1, 2011.
