COMMISSION STAFF'S SECOND INFORMATION
REQUEST TO KENTUCKY FRONTIER GAS, LLC

Pursuant to 807 KAR 5:001, Kentucky Frontier Gas, LLC ("Frontier") is to file with the Commission the original and six copies of the following information and documentation, with a copy to all parties of record. The information requested herein is due within 20 days of the date of this request. Responses to requests for information and production of documents shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity, that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Frontier shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though

correct when made, is now incorrect in any material respect. For any request to which Frontier fails or refuses to furnish all or part of the requested information, Frontier shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.


Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations.

1. Refer to the Odorization Reports filed by Frontier for its Kentucky gas systems in response to Commission Staff's First Information Request ("Staff's First Request"), Item 1. Explain whether there are any odorization reports that were requested but not provided. If so, provide all omitted reports or explain why they cannot be provided.

2. The odorization reports filed by Frontier provide various levels of detail; however, the information requested in Staff's First Request, Item 2, is not specifically addressed. Provide the locations and number of checkpoints for each gas system listed in the application.

3. Frontier's May 31, 2011 filing did not address Items 3, 4, and 5 contained in Staff's First Request. Provide the information as originally requested or explain why it cannot be provided.

4. Explain whether Frontier has continued to be in compliance with 807 KAR 5:022, Section 13(17) regarding the odorization of gas for each of its Kentucky gas systems during the pendency of this case.
