ORDER

On December 1, 2011, Kenergy Corp. ("Kenergy") filed a Petition for Reconsideration requesting the Commission to reconsider its November 17, 2011 Order in this matter. Specifically, Kenergy requests the Commission to reconsider the following items: (1) the date on which it ordered depreciation rates to become effective and (2) the energy rates for Schedules 34 and 35 as set forth in Appendix B to the November 17, 2011 Order. Pursuant to an Order issued on December 5, 2011, the Commission granted Kenergy's request to reconsider the above-mentioned items.

On December 6, 2011, Kenergy filed an Amended Petition for Reconsideration to further request "that any relief granted on Petition for Rehearing in the Big Rivers Electric Corporation rate case [sic] No. 2011-00036 flow through herein, subject to any response Kenergy files to Big Rivers' petition for rehearing." The Commission takes administrative notice that Big Rivers Electric Corporation ("Big Rivers") has filed a petition requesting a rehearing on various issues in its base rate case.¹

On December 8, 2011, the Commission granted Big Rivers' request for rehearing to consider the issues raised by Big Rivers and determine whether or not the Commission's November 17, 2011 Order should be modified or amended.

Having reviewed the amended petition and being otherwise sufficiently advised, the Commission finds that Kenergy has established good cause to reconsider the matter. The Commission notes that any potential modification to the Big Rivers' November 17, 2011 Order in Case No. 2011-00036 as a result of the Big Rivers' petition for rehearing could have an impact on the instant matter.

IT IS THEREFORE ORDERED that Kenergy's Amended Petition for Reconsideration is granted.
