ORDER

On February 10, 2011, Grayson County Water District ("Grayson") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Grayson produces water at its treatment facilities and purchases water from the City of Leitchfield ("Leitchfield").
- 2. Leitchfield notified Grayson that, effective February 17, 2011, its volumetric wholesale rate to Grayson would increase from \$1.946 per 1,000 gallons to \$2.031 per 1,000 gallons.
- 3. Grayson misstated the base rate charged by Leitchfield in the application. Grayson calculated the purchased water adjustment factor using the correct base rate of \$1.946 per 1,000 gallons.
- 4. Grayson proposed a purchased water adjustment factor of \$0.04 per 1,000 gallons.
- 5. During the 12 months ending December 31, 2010, Grayson purchased 171,880,000 gallons of water from Leitchfield and sold 355,495,968 gallons. The

increase in the cost of purchased water is \$14,609.80, resulting in a purchased water adjustment factor of \$0.04 per 1,000 gallons.

- 6. Grayson proposed an effective date of March 17, 2011.
- 7. The purchased water adjustment factor of \$0.04 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. The rates proposed by Grayson are approved.
- 2. The purchased water adjustment factor of \$0.04 per 1,000 gallons as calculated in Appendix A is approved.
- 3. The rates in Appendix B are approved for water service rendered on or after March 17, 2011.
- 4. Grayson's proposed tariff sheet filed with the application, showing the rates approved herein, is approved.
