### ORDER

On February 11, 2011, Sharpsburg Water District ("Sharpsburg") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Sharpsburg purchases water from Bath County Water District ("Bath District") and the city of Carlisle ("Carlisle").
- 2. Bath District notified Sharpsburg that, effective February 15, 2011, its volumetric wholesale rate to Sharpsburg would increase from \$2.79 per 1,000 gallons to \$2.83 per 1,000 gallons.
- 3. Sharpsburg proposed a purchased water adjustment factor of \$0.04 per 1,000 gallons.
- 4. During the 12 months ending December 31, 2010, Sharpsburg purchased 75,165,000 gallons of water from Bath District and 37,025,700 gallons of water from Carlisle and sold 83,667,100 gallons. The increase in the cost of purchased water is \$3,006.60, resulting in a purchased water adjustment factor of \$0.04 per 1,000 gallons.

5. The purchased water adjustment factor of \$0.04 per 1,000 gallons is fair, just, and reasonable and should be approved.

#### IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment factor of \$0.04 per 1,000 gallons as calculated in Appendix A is approved.
- 2. The rates in Appendix B, attached hereto and incorporated herein, are approved for water service that Sharpsburg rendered on or after February 15, 2011.
  - 3. Sharpsburg's proposed tariff sheet is approved.
