#### ORDER

On February 18, 2011, West Shelby Water District ("West Shelby") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

- West Shelby purchases water from Shelbyville Municipal Water & Sewer Commission ("Shelbyville") and Louisville Water Company ("Louisville").
- 2. Shelbyville notified West Shelby that, effective February 19, 2011, its volumetric wholesale rate to West Shelby would increase from \$1.83 per 1,000 gallons to \$1.90 per 1,000 gallons.
- 3. West Shelby proposed a purchased water adjustment factor of \$0.02 per 1,000 gallons.
- 4. During the 12 months ending December 31, 2010, West Shelby purchased 69,824,000 gallons of water from Shelbyville, 213,163,000 gallons of water from Louisville, and sold 260,177,300 gallons. The increase in the cost of purchased water is \$4,887.68, resulting in a purchased water adjustment factor of \$0.02 per 1,000 gallons.

- 5. West Shelby proposed an effective date of April 1, 2011.
- 6. West Shelby misapplied the purchased water adjustment factor to its current rates.
- 7. The purchased water adjustment factor of \$0.02 per 1,000 gallons is fair, just, and reasonable and should be approved.

### IT IS THEREFORE ORDERED that:

- 1. The rates proposed by West Shelby are denied.
- 2. The purchased water adjustment factor of \$0.02 per 1,000 gallons as calculated in Appendix A is approved.
- 3. The rates in Appendix B, attached hereto and incorporated herein, are approved for service rendered on or after April 1, 2011.
- 4. Within 20 days of the date of this Order, West Shelby shall file revised tariff sheets with the Commission showing the rates approved herein and reflecting that they were approved by this Order.
