ORDER

On February 21, 2011, Pendleton County Water District ("Pendleton District") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Pendleton District purchases water from Northern Kentucky Water District ("Northern Kentucky") and the city of Falmouth ("Falmouth").
- 2. Northern Kentucky notified Pendleton District that it would increase its wholesale water rates effective March 1, 2011. Northern Kentucky's wholesale water rate to Pendleton District would increase from \$2.97 per 1,000 gallons to \$3.05 per 1,000 gallons.
- 3. Pendleton District proposes a purchased water adjustment factor of \$0.06 per 1,000 gallons.
- 4. Pendleton District proposes to increase the water rates to its customers effective March 1, 2011.



- 5. During the 12 months ending December 31, 2010, Pendleton District purchased a total of 104,902,552 gallons of water from Northern Kentucky and 61,319,440 gallons of water from Falmouth and sold a total of 146,294,277 gallons of water. The increase in the cost of purchased water is \$8,392.20, resulting in a purchased water adjustment of \$0.06 per 1,000 gallons.
- 6. A purchased water adjustment of \$0.06 per 1,000 gallons is fair, just, and reasonable.

IT IS HEREBY ORDERED that:

- 1. Pendleton District's proposed rates are approved.
- 2. The purchased water adjustment increase of \$0.06 per 1,000 gallons as calculated in Appendix A is approved and the rates in Appendix B, attached hereto and incorporated herein, are approved for services rendered on and after March 1, 2011.
- 3. The tariff sheets filed with Pendleton District's application are accepted as filed.
