ORDER

On May 31, 1996, in Case No. 1994-00433, the Commission approved rates for Bluegrass Gas Sales, Inc. ("Bluegrass") and provided for their further adjustment on a quarterly basis in accordance with Bluegrass's gas cost adjustment ("GCA") clause.¹

On March 2, 2011, Bluegrass filed its proposed GCA to be effective April 1, 2011.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Bluegrass's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Bluegrass's notice sets out an Expected Gas Cost ("EGC") of \$5.9075 per Mcf, which is an increase of \$.0799 per Mcf from its previous EGC of \$5.8276 per Mcf.
 - 3. Bluegrass's notice sets out no current guarter Refund Adjustment.
- 4. Bluegrass's notice sets out a current quarter Actual Adjustment ("AA") of (\$.1269) per Mcf. Bluegrass's total AA is (\$.0247) per Mcf, which is a decrease of \$.1145 per Mcf from its previous total AA of \$.0898 per Mcf.

- 5. Bluegrass's notice sets out a current quarter Balance Adjustment ("BA") of \$.0030 per Mcf. Bluegrass incorrectly transferred (\$.0219) to Schedule I of its application in calculating its total BA. Bluegrass's total BA should be \$.1851 per Mcf, which is an increase of \$.0189 per Mcf from its previous total BA of \$.1662 per Mcf.
- 6. Bluegrass's GCA is \$6.0679 per Mcf, which is a decrease of \$.0157 per Mcf from its previous rate of \$6.0836 per Mcf.
- 7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Bluegrass on and after April 1, 2011.

IT IS THEREFORE ORDERED that:

- 1. Bluegrass's proposed rates are denied.
- 2. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing for service rendered on and after April 1, 2011.
- 3. Within 20 days of the date of this Order, Bluegrass shall file with the Commission its revised tariffs setting out the rates approved herein, reflecting that they were approved pursuant to this Order.
