ORDER

On February 16, 1999, in Case No. 1998-00499,¹ the Commission approved rates for Jefferson Gas Transmission Company ("Jefferson") and provided for their further adjustment in accordance with Jefferson's Gas Cost Adjustment ("GCA") clause.

On March 29, 2011, Jefferson filed its proposed GCA to be effective May 1, 2011.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Jefferson's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Jefferson's proposed Expected Gas Cost ("EGC") is \$3.2978 per Mcf, which is a decrease of \$.0179 per Mcf from the previous EGC of \$3.3157 per Mcf.
 - 3. Jefferson's notice sets out no current quarter Refund Adjustment.

- 4. Jefferson's notice sets out a current quarter Actual Adjustment ("AA") of (\$.2461) per Mcf. Jefferson's total AA is (\$.7255) per Mcf, which is an increase of \$.3167 per Mcf from the previous total AA of (\$1.0422) per Mcf.
- 5. Jefferson's GCA is \$2.5723 per Mcf, which is an increase of \$.2988 per Mcf from the previous GCA of \$2.2735 per Mcf.
- 6. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Jefferson on and after May 1, 2011.

IT IS THEREFORE ORDERED that:

- 1. The rates in the Appendix to this Order, attached hereto and incorporated herein, are approved for billing for service rendered by Jefferson on and after May 1, 2011.
- 2. Within 20 days of the date of this Order, Jefferson shall file its revised tariffs with this Commission setting out the rates authorized herein and reflecting that they were approved pursuant to this Order.
