ORDER

On March 30, 2011, North Shelby Water Company ("North Shelby") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. North Shelby purchases water from Shelbyville Municipal Water and Sewer Commission ("Shelbyville"), Frankfort Electric and Water Plant Board ("Frankfort"), Louisville Water Company ("Louisville"), and West Shelby Water District ("West Shelby").
- 2. Shelbyville notified North Shelby that, effective April 1, 2011, its volumetric wholesale rate to North Shelby would increase from \$1.70 per 1,000 gallons to \$1.765 per 1,000 gallons, and Frankfort² notified North Shelby that, effective April 1, 2011, its volumetric wholesale rate to North Shelby would increase from \$1.704 per 1,000 gallons to \$1.81 per 1,000 gallons.

- 3. North Shelby proposed a purchased water adjustment factor of \$0.05 per 1,000 gallons.
- 4. During the 12 months ended February 28, 2011, North Shelby purchased 8,858,600 gallons of water from Shelbyville, 173,981,000 gallons from Frankfort, 277,705,000 gallons from Louisville, and 440,050 gallons from West Shelby and sold 405,093,800 gallons.
- 5. North Shelby's cost of purchased water increased \$19,017.80 and results in a purchased water adjustment factor of \$0.05 per 1,000 gallons.
- 6. The purchased water adjustment factor of \$0.05 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. The rates proposed by North Shelby are approved.
- 2. The purchased water adjustment factor of \$0.05 per 1,000 gallons as calculated in Appendix A is approved.
- 3. The rates in Appendix B are approved for water service rendered on or after April 1, 2011.
 - 4. North Shelby's proposed tariff sheet is approved.
