# ORDER

On April 14, 2011, Montgomery County Water District No. 1 ("Montgomery County") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Montgomery County purchases water from Mount Sterling Water and Sewer Commission ("Mount Sterling").

2. Mount Sterling notified Montgomery County that, effective May 1, 2011, its volumetric wholesale rate to Montgomery County will increase from \$2.07 per 1,000 gallons to \$2.34 per 1,000 gallons.

Montgomery County proposes a purchased water adjustment factor of
\$0.33 per 1,000 gallons.

4. During the 12 months ending February 28, 2011, Montgomery County purchased 44,336,728 gallons of water from Mt. Sterling and sold 36,964,820 gallons.

The increase in the cost of purchased water is \$11,970.91, resulting in a purchased water adjustment factor of \$0.33 per 1,000 gallons.

5. The purchased water adjustment factor of \$0.33 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:


1. Montgomery County's proposed rates are approved.

2. The purchased water adjustment factor of \$0.33 per 1,000 gallons as calculated in Appendix A hereto is approved.

3. The rates in Appendix B are approved for service rendered on or after May 1, 2011.

4. Montgomery County's proposed tariff sheet is approved.
