ORDER

On April 25, 2011, Southeast Daviess County Water District ("Southeast Daviess") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Southeast Daviess purchases water from Owensboro Municipal Utilities ("OMU").
- 2. OMU notified Southeast Daviess that, effective June 1, 2011, its volumetric wholesale rate to Southeast Daviess would decrease from \$1.62 per 1,000 gallons to \$1.50 per 1,000 gallons.
- 3. Southeast Daviess proposed a purchased water adjustment factor of (\$0.13) per 1,000 gallons.
- 4. During the 12 months ending March 31, 2011, Southeast Daviess purchased 602,734,600 gallons of water from OMU and sold 567,295,140 gallons.

The decrease in the cost of purchased water is \$72,328.15 and results in a purchased water adjustment factor of (\$0.13) per 1,000 gallons.

- 5. Southeast Daviess proposed an effective date of June 1, 2011.
- 6. The purchased water adjustment factor of (\$0.13) per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. Southeast Daviess' rates are approved.
- 2. The purchased water adjustment factor of (\$0.13) per 1,000 gallons, as calculated in Appendix A, is approved.
- 3. The rates in Appendix B are approved for services rendered on or after June 1, 2011.
 - 4. Southeast Daviess' proposed tariff sheets are approved.
