ORDER

On May 13, 2011, East Kentucky Power Cooperative, Inc. ("East Kentucky") filed a motion, on behalf of itself and its 16 member distribution cooperatives, requesting that this case be held in abeyance for at least 60 days from the granting of this motion to provide sufficient time to hold an informal conference with Commission Staff to discuss and clarify issues related to the pending demand-side management tariffs. The motion states that, based on the information request appended to the Commission's April 29, 2011 Order, East Kentucky and its 16 member distribution cooperatives realized that it would be beneficial to have an informal conference before responding to the information request.

Based on the motion and being otherwise sufficiently advised, the Commission finds good cause to extend the due date for the filing of responses to the information request appended to our April 29, 2011 Order. Finally, we find that this case should not be held in abeyance as requested, since doing so would prevent the scheduling and convening of the requested informal conference.

 Order shall be filed no later than 60 days from the date of this Order.
- 2. An informal conference shall be scheduled by staff notice in the near future.
