
On June 1, 2011, Kentucky Utilities Company ("KU") tendered for filing an application, pursuant to KRS 278.020(1) and 278.183, requesting approval to construct air quality control facilities and approval of an amended environmental compliance plan and rate surcharge. By letter dated June 14, 2011, the Commission notified KU that its tendered application was being rejected for filing due to the omission of the paper copies of the appendices to the testimony of witness John N. Voyles, Exhibit JNV-2, and the exhibits to the testimony of witness Gary H. Revlett. KU subsequently tendered, on June 16, 2011, an original and one paper copy of the previously omitted appendices and exhibits, and a motion requesting a deviation from 807 KAR 5:001, Section 3(3) and 8(2), which requires an application to be filed on paper and be accompanied by ten copies. KU's motion states that due to the voluminous nature of the omitted appendices and exhibits, its application as originally tendered included electronic copies only, not paper copies. The motion further requests that the Commission find that KU has substantially complied with the applicable regulations by its tender of an original and

one paper copy of the previously omitted appendices and exhibits, along with the originally tendered electronic copies.

Based on the motion and being otherwise sufficiently advised, the Commission finds that the omitted appendices and exhibits are voluminous and that the filing of an original and one paper copy, rather than the required ten copies, will not hinder our investigation and processing of this case. Thus, we find good cause to grant KU a deviation under 807 KAR 5:001, Section 14, and to accept its application for filing as of June 16, 2011, the date that KU tendered the original and one paper copy of the omitted appendices and exhibits.

IT IS THEREFORE ORDERED that KU's request for a deviation is granted and its application is accepted for filing as of June 16, 2011.
