## <u>ORDER</u>

On June 9, 2011, McKinney Water District ("McKinney District") applied to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup> Having reviewed the application and being otherwise sufficiently advised, the Commission finds that:

1. McKinney District purchases its water requirements from the city of Eubank ("Eubank") and the city of Stanford ("Stanford").

2. On June 27, 2011, Eubank increased its rate for wholesale water service to McKinney District.

3. Eubank's rate for wholesale water service is a three-step declining block rate. As a result of its recent rate adjustment, the second and third steps of Eubank's wholesale water rate are changing.<sup>2</sup>

4. McKinney District proposes a purchased water adjustment factor of \$0.12 per 1,000 gallons of water.

5. McKinney District proposes to adjust its rates effective July 15, 2011.

6. During the 12 months ending April 30, 2011, McKinney District purchased 22,373,800 gallons of water from Eubank and 110,841,000 gallons of water from Stanford. It sold 92,276,800 gallons of water during the same period.

7. As shown in Appendix A of this Order, Eubank's increased wholesale rate will result in an increase of \$11,156.90 in McKinney District's cost for purchased water. This increased cost results in a purchased water adjustment factor of \$0.12 per 1,000 gallons.

8. The purchased water adjustment factor of \$0.12 per 1,000 gallons is fair, just and reasonable and should be approved.

IT IS THEREFORE ORDERED that:


1. McKinney District's proposed rates are approved.

2. The purchased water adjustment factor of \$0.12 per 1,000 gallons as calculated in Appendix A is approved.

3. The rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on or after July 15, 2011.

4. McKinney's proposed tariff sheets filed with the application, showing the rates approved herein, are approved.
